3	This is a pass-fail course, and is totally low stress... except that you do have to prepare opening / closing arguments and direct / cross examinations and put on a trial for jurors brought in from the community. Prof. Mauldin is great -- really nice guy, tons of trial experience (he's been the Clarke County D.A. since 2004, I believe), and has a lot of wisdom to impart. That said, if you're looking for an organized, detailed, and exhaustive survey of trial practice, this is not the course for you. He paints in broad strokes and we did not learn a lot of substantive law - like basic rules of evidence, for example.
