As Associate Dean for Academic Affairs, I am responsible for the law school’s academic programs and student affairs. I lead our U.S. News strategic efforts and ABA and university-policy compliance. I also work with the Dean on development and communications matters. I lead a team with ten direct reports, including all legal writing instructors, the Associate Directors of Student Affairs, and the Law School Registrar. I am also the supervisor of all part-time instructors.

- Led, along with the Dean, efforts that elevated and solidified the University of Georgia School of Law’s position as the top-ranked law school in Georgia and highest ranking ever (at #20) in U.S. News and World Report
- Completed a successful university-level program review for all academic degree programs
- Led, along with the chair of our site-visit committee, Georgia Law’s 2023 ABA and AALS Site Visit
- Led creation of a new “Lawyering” course to satisfy revised ABA Standard 303 and related curricular objectives
- Readjusted personnel roles to create more efficient and better service from student and academic affairs, while reducing personnel costs
- Worked directly with a donor to secure a \$1 million gift to establish a new faculty chair after that donor asked me to counsel him on his family’s philanthropic efforts

- Worked with the Dean and Advancement Office to develop a Mental Health Fund with a donor to provide additional wellness resources to students and develop new wellness programming
- Established “Common Grounds” program to encourage students to have difficult, civil conversations on controversial topics
- Established a series of lunches with student leaders and student affinity groups to address student concerns and improve inclusivity at the law school, and provide progress reports to participants
- Instituted an automated-degree-audit project to improve the accuracy and speed of degree audits
- Implemented new course-scheduling software and processes to increase staff efficiency and student satisfaction
- Oversee all student orientation activities and teach a two-week course before orientation to introduce students, especially those from marginalized backgrounds, to law-school pedagogy and legal cultural norms and expectations
