

3 Year JD/MBA curriculum

- This curriculum is intended for students who have work experience prior to enrolling in Year 1 of the JD program at the University of Georgia School of Law. All students are strongly encouraged to meet with the Director of Dual Degree programs for the School of Law and the Director of Student Services for the MBA program on a regular basis to monitor their progress in this program.
- This program requires at least 71 JD Credit hours, including the 1L curriculum, Corporations as the 1L Spring Elective, the 2L writing requirement, JURI Capstone, practical skills hours, and Law and Ethics of Lawyering. There is some flexibility as to when the JURI Capstone, Law and Ethics of Lawyering, and the practical skills requirements are met.
- This program requires 36 MBA credit hours and the MBA Capstone Requirement. 12 of those hours should be in Fall of Year 2. Students can meet their MIST requirement in either MBA year.
