* First session – Wednesday 8/21 at 11:00 a.m. in Room J:

Aug. 21 The Basics: Things Every New Law Student Needs to Know

As you are getting used to reading cases and navigating your classes, this session will provide tips specific to each of your first-year subjects and alert you to unfamiliar terminology, legal doctrines, and principles that cut across all of your courses.

* Remaining sessions – on the following **Mondays** at **1:00 p.m.** in **Room J**:

Aug. 26 Beyond the Case Brief: What Are You Actually Supposed to be Getting from All of This?

What is the end game here? What will you actually be tested on? The answers to those questions are unique to law school and should dictate how you approach the cases you are reading, how you take notes in class, and how you study outside of class. In this session, we will answer those questions and look at some typical law school exam questions to help you better focus on what matters.

Sept. 9 Starting to Construct the Puzzle – Synthesizing for Classes

You understand the individual cases, but understanding how they fit together is what will matter for exams. This session will focus on how you can begin to pull clusters of cases together and start to lay the groundwork for outlining.

Sept. 23 Outlining: Your Biggest Assignment (That is Never Assigned)

Creating your own outline of a course is critical to making sure you will ultimately be prepared for the exam. Now is the time to begin that process, but make no mistake about it: there are wrong ways to outline. This session will show you how to effectively begin pulling together the case briefs, class notes, hypotheticals, rules, and other bits of materials you are accumulating into manageable and organized study aids that will help you at exam time.

Oct. 7 Who's Afraid of the (big, bad) Bluebook?

Wrestling with <u>The Bluebook</u> is rite of passage for all new law students, and learning to do it properly is critical for your legal research and writing assignments, for Journal and Law Review, and for clerkships and practice. This session will provide tips to help you master the ins and outs of the <u>Bluebook</u> (you may even find that it can be kind of fun!) and will focus largely on case citation. This is a hands-on workshop, so bring your Bluebook with you.

Oct. 21 <u>Exam-Writing Series – Session 1: Spotting & Framing the Issues</u>

This session will focus on unearthing and framing issues and sub-issues in essay exam questions, and on effectively organizing your discussion of those issues.

Oct. 28 <u>Exam-Writing Series – Session 2: Dealing with the Rules</u>

How much "rule" is enough in an exam answer? How much is too much? What about exceptions to rules? This session will focus on these questions and others related to dealing with rules in exam answers.

Nov. 11 <u>Exam-Writing Series – Session 3: Explaining the Analysis</u>

Application of the relevant rules to the facts you are given on an exam is the heart of a law school essay exam answer. This workshop will focus on how to explain your analysis of the facts in a way that earns maximum points.

Nov. 25 Exam-Writing Series – Session 4: "Pencils Up"

With exams just around the corner, this session focuses on last minute practical advice for reading week as well as exam day -- everything from skinny and attack outlines, to anticipating and preparing for exam questions, to managing your time on an exam.



Student Affairs

The following is a non-verbatim summary of information from the University of Georgia's Code of Conduct. For a complete version of the Code of Conduct, visit **conduct.uga.edu**.

Conduct regulations apply to any behavior, <u>on or off University premises</u>, which adversely affects the University community or the pursuit of its objectives. A student is not immune to prosecution by local, state, or federal law enforcement agencies irrespective of whether the University initiates conduct proceedings; accordingly, <u>a conduct case may proceed in the absence of a criminal prosecution</u>. Students have a responsibility to know and follow the conduct regulations. Violations will result in action by the Office of Student Conduct in addition to any action taken by the Law School.

STUDENT CONDUCT RECORDS

Student conduct records may be requested or considered in many states' character and fitness process for Bar Admission. Per the University System of Georgia's Board of Regents records retention policy, conduct records are maintained for five years from a student's last date of enrollment. *Note: There is no expungement of conduct records*.

CONDUCT RESOLUTION PROCESS

Incident Reported

Through a complaint, via police reports, or via referral

Office of Student Conduct (OSC)

- Incident is reviewed and alleged violations of the Code of Conduct are examined.
- If the administrative officer finds that the report alleges violations of conduct regulations, he/she
 will initiate the conduct process.
- Student will receive an email notifying them of the alleged conduct regulation violation(s), a request to make an appointment, and administrative officer contact information.
- Student will arrange meeting time to discuss the case with the assigned administrative officer.
- During the meeting, student will be provided information about the conduct process and will have the opportunity to provide information about the incident.
- If administrative officer finds enough information to move forward with the alleged violations, case is resolved informally or formally.

No Action Administrative officer does not find enough information to move forward with conduct process.

Informal Resolution

- Student and administrative officer agree that an informal resolution is a reasonable outcome.
- Student accepts responsibility for violation(s) of the Code of Conduct.
- Student agrees with sanctions assigned for violation and waives the right to an appeal.
- Violation of Code is noted in the resolution agreement.
- The student's file, including the resolution, is maintained per the Board of Regents records retention policy.

Appeal

 Appeals must be filed with the OVPSA within five business days of receipt of the decision.

Formal Resolution

- Student can request to have the case resolved formally.
- Investigation ensures and an investigator can interview student, alleged victim, witnesses, review other documents or evidence, and will summarize the investigation in writing.
- If student is ultimately charged with any violations, he/she will have the opportunity to respond in writing and the investigation report will be updated.
- Following the submission of the final investigative report, a Notice of Hearing will be delivered to the student.
- Student is responsible for presenting his/her case at the hearing. An advisor may assist the student but may not speak directly to the panel or witnesses during the hearing. An advisor from University Judiciary is available to the student. Student may instead choose another advisor at his/her expense.
- Student advocate will present the University's case.
- Outcome of hearing is decided by a hearing panel composed of two University Judiciary members and one faculty/staff hearing administrator.
- Panel decides an outcome of hearing using preponderance of the evidence standard, and if applicable, assigns sanctions.

MINIMUM SANCTIONS FOR ALCOHOL AND OTHER DRUG (AOD) VIOLATIONS

- When a student is responsible for the following violations, the minimum sanctions assigned will be: <u>AOD education</u> program and probation for twelve (12) months from the date of resolution.
 - First violation for consumption, use, or distribution of alcohol, facilitating the use of alcohol by others, or disruptive or disorderly conduct caused by the influence of alcohol | First violation for illegal use, possession or distribution of illegal drugs/controlled substances.
- When a student is responsible for the following violations, the minimum sanctions assigned will be: <u>Suspension from the institution</u>.
 - o First violation for sale of illegal drugs or controlled substances: Any subsequent violation, while on probation for a prior alcohol/drug violation, involving the operation of a motor vehicle after consumption of alcohol and/or use of drugs | Any second violation, regardless of probation status, involving the operation of a motor vehicle after consumption of alcohol and/or use of drugs when a prior violation also involved the operation of a motor vehicle after consuming alcohol and/or using drugs.
- Additional sanctions may be imposed and are determined by circumstances of the case and student's prior record.

COMMONLY CITED CONDUCT REGULATIONS

2. Other Acts of Dishonestv

- 1. Furnishing false information to any University official, office, or other law enforcement officer.
- Forgery, alteration, or misuse of any document, record, or instrument of identification, or possession of any false identification or identification belonging to another person with dishonest intent.
- Causing, condoning, or encouraging the completion of any University record, document, or form dishonestly, including but not limited to omitting facts which are material for the purpose of which the record, document, or form is submitted.

3. Disorderly Conduct

The University of Georgia fully supports the marketplace of ideas and shall enforce its conduct regulations in accordance with the freedoms of speech and expression protected by the United States and Georgia Constitutions.

- Intentional or reckless disruption or obstruction of teaching, research, administration or other University activities.
- Conduct that intentionally or recklessly causes or provokes a disturbance that disrupts the academic pursuits, or infringes upon the rights, privacy, or privileges of another person.
- 3. Conduct that threatens or endangers the health or safety of another person, including but not limited to physical violence, abuse, intimidation, and/or coercion; or violation of a legal protective order.
- 4. Sexual Misconduct, including but not limited to dating violence, domestic violence, nonconsensual sexual contact, nonconsensual sexual penetration, sexual exploitation, sexual harassment, and stalking, or any other form of conduct prohibited by the Sexual Misconduct Policy found at: https://eoo.uga.edu/title_ix_sexual_misconduct/smpolicy/.
- Violation of published University policies, rules, or regulations.
- 6. Failure to comply with directions of any University official, office or other law enforcement officer acting in performance of their duties and/or failure to identify oneself to these persons when requested to do so.

4. Alcohol & Other Drug Related Misconduct

- Use or possession of alcoholic beverages except as permitted by law and University Alcohol and Other Drug Policies.
- 2. Providing, distributing, selling, or facilitating the use or possession of alcoholic beverages except as permitted by law and University Alcohol and Other Drug Policies.
- 3. Disruptive or disorderly conduct caused by the influence of alcohol and/or other drugs.
- 4. Use or possession of narcotic or other controlled substances except as permitted by law and University Alcohol and Other Drug Policies.
- 5. Providing, distributing, selling, or facilitating the use or possession of narcotic or other controlled substances except as permitted by law and University Alcohol and Other Drug Policies.

5. Theft, Damage & Disregard for Property

- 1. Taking, attempting to take, or keeping in one's possession any property or item, including but not limited to any tangible possession, information, or account, without proper authorization.
- 2. Malicious or unwarranted damage or destruction, or attempted damage or destruction, of any property or item, including but not limited to any tangible possession, information, or account.

7. Weapons

1. Possessing firearms, explosives, other weapons, or dangerous chemicals on University property unless permitted by law.

8. Unauthorized Entry or Use

- Unauthorized entry or attempted entry into any property, including but not limited to any building, office, or other facility, automobile, backpack, or account.
- 2. Making or attempting to make unauthorized use of any building, office, or other facility, information, or accounts.

12. Hazing

 Participating in, condoning, encouraging, requiring, or allowing opportunity for hazing.

Important Law School Policies to Follow

Free Expression

The University of Georgia School of Law encourages a robust exchange of ideas in accordance with the First Amendment. To that end, student organizations may plan events in accordance with the content-neutral time, place, and manner restrictions outlined by the University and in the law school's student organization handbook (available on

eLC for student organization leaders).

Moments of disagreement or even offense may naturally arise as diverse ideas are exchanged. While these moments may be uncomfortable, they are also educational. Attempts to prevent invited guests from speaking will be subject to discipline under the UGA Student Code of Conduct and/or the School of Law Faculty Policy on

Professionalism.

Students who disagree with the speaker may pose questions of the speaker as part of any open question-and-answer period provided by the organizers, and students may arrange for their own invited speakers or events, consistent with the content-neutral time, place, and manner restrictions outlined by UGA and law-school policies, to present their views.

Plagiarism

Plagiarism is unacceptable and will not be tolerated at the University of Georgia Law School. Plagiarism is the submission of another's work as one's own. It includes:

 use of another's exact words without use

- of quotation marks and acknowledgement of that use in a footnote or end-note;
- use of another's organizational scheme without acknowledgement of that use in a footnote or endnote;
- either close paraphrasing of the work of another without attribution or submission of a work which

is largely a paraphrasing of another's work without attribution.

Each student is obliged to be aware of the policy against plagiarism and lack of awareness of the policy does not excuse a violation of it. No student shall be permitted to graduate while charges of plagiarism are pending against that student.

Professionalism

The Law School's expectation of its students' professional behavior is embodied in the Law School Student Oath taken by each new student at orientation:

I acknowledge that my

conduct, inside and outside of the law school, reflects on the entire University of Georgia Law School community, past, present and future.

- I will conduct myself with dignity and civility and will treat all fellow students, staff, faculty, alums, and
- employers with courtesy and respect.
- I promise to live up to the highest standards of the legal profession and uphold the highest standard of academic honesty and ethical practice throughout law school and the remainder of my professional career.



DUTIES OF DISCLOSURE

You must execute this agreement by completing the required Duties of Disclosure quiz in the "School of Law Orientation 2024" eLC course no later than Sunday, September 1, 2024. If you need to make further disclosures before executing this agreement, you must arrange to meet with your respective Admissions representative by Friday, August 23, 2024.

Your enrollment in the School of Law signals your entry into the legal profession. The legal profession requires its members to exhibit, at all times, the highest level of professionalism, character, honesty, and integrity. A failure to live up to these ideals can adversely affect your ability to be admitted to the Bar. It is important that you determine the applicable character, fitness, and other requirements for admission to the Bar in each jurisdiction in which you intend to seek admission to the Bar.

I. Duty to Disclose in Law School Application

When you submitted your application for admission to the University of Georgia School of Law, you responded to the following questions:

- 1. Have you ever been dropped, suspended, warned, placed on scholastic or disciplinary probation, expelled or requested to resign from any college, university, or law school, otherwise subjected to discipline by any such institution, or requested or advised by any such institution to discontinue your studies therein?
 - Have you ever been formally charged with cheating, lying, or otherwise taking unfair advantage of fellow students at any college, university, or law school you attended or are presently attending?
 - Regardless of whether the record has been expunged, cancelled or annulled, or whether no record was made, have you ever been subject to proceedings before a school honor court or council (or any similar body)?
- 2. Excluding only parking violations, have you ever been detained, arrested, formally accused, cited, or prosecuted for the violation of any law? You must disclose each instance, even if the charges were dismissed; you were acquitted; you pled nolo contendere; adjudication was withheld; your conviction was reversed, set aside, or vacated; or the record was sealed or expunged.

- 3. Have you ever been discharged from the armed forces other than honorably or are charges pending which could result in such an outcome?
- 4. Have you ever been subject to disciplinary sanctions while holding a professional license or are charges pending, which could result in such an outcome?

When you submitted your application, you certified that the information provided in your application was true and complete. In addition, you indicated that you understood and agreed that providing false information or failing to disclose information material to the Law School's admission decision is grounds for punitive action, which could include rescission of your admission or dismissal from the Law School.

Most Bar Admission authorities require your law school application when you apply for admission to the Bar. Your application answers to the above questions must be consistent with the information that you provide to the Bar.

If you did not disclose all requested information in your application, or if you are unsure, <u>do NOT</u> complete the online eLC quiz. Instead, please contact your respective Admissions representative by Friday, August 23, 2024 to disclose any conduct not already disclosed on your application. This includes conduct that took place after admission but before classes begin on Tuesday, August 20, 2024.

After meeting with your Admissions representative to discuss your disclosures, you may execute this agreement by completing the online eLC quiz.

II. Continuing Duty to Disclose Post-Admission Conduct

You have a continuing duty to promptly disclose information that is responsive to the questions stated above from now until you are no longer a student at the University of Georgia School of Law. Your continuing duty also extends to periods between semesters when you are not enrolled. Disclosures regarding conduct/incidents taking place on or after Tuesday, August 20, 2024 should be made to Dr. Paula McBride, Law School Registrar, at mcbride1@uga.edu.

Your failure to disclose post-admission conduct that is responsive to the questions stated above may result in revocation of admission, suspension or dismissal after matriculation, denial of certification of graduation, or revocation of your degree.

You must execute this agreement by completing the required Duties of Disclosure quiz in the "School of Law Orientation 2024" eLC course no later than Sunday, September 1, 2024. If you need to make further disclosures before executing this agreement, you must arrange to meet with your respective Admissions representative by Friday, August 23, 2024.



School of Law - Hirsch Hall - 1st Floor








Dean Rusk Hall Maps

School of Law - Dean Rusk Hall - 1st Floor











During the summer, students can opt to work for 4-to-12 weeks in placements abroad. Students work closely with Center staff to identify placements tailored to their professional goals. Past placements have included:

- Nongovernmental organizations like War Child in the Netherlands, Boat People SOS in Thailand, and Women in Law and Development in Ghana


SEMESTER-LONG EXCHANGES

Offered in partnership with the prestigious Leuven Centre for Global Governance Studies, Global Governance Summer School continues a four-decade tradition of summer study in Belgium. Students explore global legal practice related to a variety of international, comparative, and transnational topics. Also featured in the program are professional development trips to leading legal institutions in Europe, such as the International Court of Justice, the International Criminal Court, the Iran-U.S. Claims Tribunal, NATO headquarters, as well as global law firms. This 2-week program is offered for 3 credits.

Emergency Preparedness

for UGA School of Law Students, Faculty and Staff

Three Step Checklist:

Step 1: Sign up for campus wide **UGAA***lert*, https://ugaalert.uga.edu.

UGA*Alert* is the emergency notification system at UGA. When you sign up, you may choose to receive emergency messages through your UGA email and/or mobile phone. If you choose your cell phone, please make sure to add the UGA Alert phone number – **706-542-0111** to your contacts.

<u>Step 2:</u> Download the <u>new</u> **UGASAFE** app on your mobile phone. **UGASAFE** app allows you to connect quickly with UGA Police, participate in safe walk location sharing and is an emergency resource tool at your fingertips.

Step 3: The School of Law has a <u>one-way</u> texting notification program that serves as an additional way for law school faculty, staff and students to be alerted of emergency information specific to the law school. This texting service complements your email notifications of any emergency situation, such as a school day delayed start due to inclement weather, or any circumstances that might alter the normal operations at the school. This texting feature does not take the place of your uga.edu email address that will continue to serve as the primary form of emergency communication relating to the law school. Faculty, staff and students are urged to sign up for this texting feature by following these instructions: *Text "ugaLAWalert" to 877-804-2955*. Please note that you must choose to optin to this service, and you may opt-out at any time.

Step 3: Download the University of Georgia App on your phone. It has a campus map, bus routes, parking info and is a very useful app for life in and around campus.

Remember to check your UGA email (uga.edu) often for important messages sent by the law school administration.
