Computer Labs

Sixteen desktop computers are located at the entrance of the Law Library. Seven PCs and two 27inch iMacs are available in the computer lab located in the Law Library Annex. All computer lab desktops include the Microsoft Office Suite (2010), Adobe Photoshop, and Adobe Acrobat Pro (for creating PDF documents).

Printing

Networked laser printers are available in the Annex Computer Lab and Law Library Copy Room. Prints cost \$.06 per page. You must use your UGACard to pay for printing. You can also print from your laptop or wireless device to our print kiosk also located in the Copy Room. This link will tell you how to connect:

A color printer is located in the Annex Computer lab. Color prints costs 25 cents per page. The print kiosk also offers color prints (\$.50 per page). A KIC "green photocopier," located in the library copy room, enables you to scan materials and save them to a USB drive or e-mail them to yourself. This option is free.
